- The Vendor will rent a space from the UTSR Committee at the Woodland Park Saddle Club Arena (19250 Hwy 24, Woodland Park, Co 80863).
- Friday, June 28, 2019: Set-up & Tear-Down
 - o Begin at 3:00 PM. The Bull Ride will begin at 7:00 PM.
 - o Tear-down will end by 10:00 PM
- Saturday & Sunday, June 28-29, 2019: Set-up & Tear-Down
 - Begin at 10:00 AM. The rodeo grounds will open at 12:00 PM to the public and begins at 2:00 PM
 - Tear-down ending at 7:00 PM.
- The UTSR Committee will provide a 10x10 booth space. **No electricity is available.** The Vendor will provide all decorations, tables, and equipment necessary to run the booth.
- The Vendor agrees to abide by the following guidelines:
- The Vendor may drive near the booth spaces to unload and then must park their vehicles in the designated area away from the booth set up.
- The Vendor takes responsibility for any damages or incidents that occur at his/her booth.
